Notice to Exhibitors

Members and officers of AOTC will show dogs at this trial.

Entries in these trials, Obedience and Rally, will be arranged according to jump height order in all classes in which jumps are used. Running order will be run small to tall. Jump height MUST be included on the entry form of dogs entered in classes in which jumps are used.

Entry fees for bitches entered in Obedience and/or Rally that come in season after entries close will be refunded, less a \$5 processing fee, upon receipt of a letter from a veterinarian attesting to the condition.

AOTC reserves the right to substitute a prize of equal or greater value.

Please exercise dogs in designated areas. All exhibitors are expected to clean up after their dogs in all areas of the trial grounds and at hotels.

All entries are to be mailed with fees to the Trial Secretary. Entries will not be accepted without fees or signatures.

Entry fees will not be refunded in the event that a dog is absent, excused by judge or Veterinarian, or barred from competing by action of the trial committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, strikes, or any other cause beyond the control of the club.

AOTC, their agents, employees, etc. assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, their dogs, or their property and furthermore assumes no responsibility for injury to children.

AOTC may decline any entries for cause, or may remove any dog because of disease, viciousness, or other cause. No one shall have any claim or recourse against AOTC or any official thereof.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- 3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 4. Dogs listed in the AKC Canine Partners^{sм} Program may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to vin prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary by hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by leact of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim to loss, injury or damage to this dog.
